The governing body is responsible for:

- Ensuring that the information above is published on the school website – or arranging for the information to be displayed on a website, and the address/details made known to parents
- Providing a paper copy of the information published on the website, without charge, to parents on request.
- Making sure that the information is updated as soon as is reasonably practicable following a change to that information and, in any event, at least annually

2) Website Privacy Policy

We are committed to safeguarding the privacy of our website visitors; this policy sets out how we will treat your personal information.

(1) What information do we collect?

We may collect, store, and use the following kinds of personal data:

1. Information about your visits to and use of this website;
2. Information about any transactions carried out between you and us on or in relation to this website;
3. Information that you provide to us for the purpose of registering with us, and/or leaving comments, and/or subscribing to our website services and/or email notifications.

(2) Information about website visits

We may collect information about your computer and your visits to this website such as your IP address, geographical location, browser type, referral source, length of visit and number of page views. 4. Except as provided in this privacy policy, we will not provide your information to third parties.

(5) Security of your personal data

We will take reasonable precautions to prevent the loss, misuse or alteration of your personal information. Of course, data transmission over the internet is inherently insecure, and we cannot guarantee the security of data sent over the internet.

(6) Policy amendments
